Pilgrim Scholarships

Did you know Greater Austin Emmaus has a scholarship fund to help Pilgrims with their walk registration fee? Ten percent of the Gathering offering each month is donated to the scholarship fund.

With the rising cost of Everything these days, it is sometimes tough for a Pilgrim to cover the entire registration fee. The Greater Austin Board of Directors doesn't want anyone to miss out on a walk because of the cost, so we are eager to help out with scholarships. The Board will cover 1/3 of the cost of the registration fee, and in cases of extreme need, $\frac{1}{2}$ of the cost can be covered.

Sponsors, please be sure to mention the scholarship fund if a potential Pilgrim indicates they have a financial need. Also remember that most of the Austin area churches that support Emmaus have scholarship funds to help with the remaining registration fee too. Here is all you need to do to apply for a GAE scholarship for your Pilgrim:

- 1) Print a Scholarship Request form from the Greater Austin Emmaus website, <u>www.austinemmaus.org</u>. Click on the Forms link in the left-hand menu. The Scholarship form is the third one in the list. Print and complete the form.
- 2) Mail the Scholarship Request form to the Greater Austin Emmaus Treasurer:

(Be sure to include your mailing address, email address, and phone #.) Roxie will mail the check to you to include with the Emmaus application. If the time for the Walk is less than 3 weeks away, send the completed application and additional registration fees along with the request form. Roxie will mail all to the Registrar for you.

Christ is risen! He is risen, indeed!

Soon we will celebrate and witness the most special Easter Season, beginning with Resurrection Sunday. I want to share a story heard on the **Lutheran Hour** several years ago:

The mother of a nine-year old got a call from her son's teacher. That is normally not a good thing. Preparing herself for the worst, Mom listened as the teacher said, "Today I saw something unusual and I wanted to tell you about it." That wasn't much better. The teacher continued: "Early today, during our creative writing class, I gave an assignment. I began by telling Aesop's story of the ant and the grasshopper. You know the fable: the ant works hard, the grasshopper fiddles away the time. When winter comes, the ant has enough to eat and the grasshopper asks for a handout."

Mom listened as the teacher elaborated further: "I asked the children in finish the story. Most of the class wrote, 'The ant shared and both lived happily ever after.' A few had the ant saying, 'Sorry, Mr. Grasshopper, I only have enough for myself. If I share, we both starve.' But your son ended the story in a unique way. His story ended, 'The ant gave all of his food to the grasshopper and the grasshopper lived happily, but the ant died.' At the bottom of his assignment, your son drew a cross."

The ending the other children wrote could have been the ending to our story, as well. Because of our sin, we, like the grasshopper, are doomed to die. We want to know, "Is there any help, any hope, any way we can escape?"

Philosophers have concluded we are on our own. Free thinkers say we can live with our sin, deny them, or forget them. That's no help. Some of the world's religions say, "You have to work hard, *very hard*, if you're going to appease your god." Sadly, they can't say when or if a person has done enough. That's no help, either.

Only Christianity says that God, in the person of Jesus, came down to earth and took our place. Only Christianity speaks of a Savior who endured hunger so we would be filled; went without an earthly home so we might have a heavenly home; suffered so we could be saved; and died so we might live.

Jesus took our place. Jesus' resurrection guarantees our happy ending -- an ending made possible by the Savior who is the Way, the Truth, and the Life. That is the resurrection message we proclaim.

Greater Austin Emmaus 4th Day Group - Board of Directors Meeting

The Greater Austin Emmaus 4th Day Group Board of Directors met on Thursday, March 4th, 2010 at Bethany United Methodist Church. In attendance were: Gene McConnell; Bob Duplantis; Diane Merwarth; Roxie Greenway; Bud Broeker; Leslie Smith; Cortney Smith; Sandy Brooks; Keith Bible; Don Greenway; and Rev. Georgia Stone.

The meeting was called to order at 7:00 PM by Gene McConnell, with an opening prayer by Cortney Smith. The minutes of the previous Board Meeting were approved as written on a motion by Diane Merwarth, seconded by Sandy Brooks. The finance report was given by Roxie Greenway, and was approved by a motion from Sandy Brooks with a second from Gene McConnell. Ending balance as of 02/28/10 is \$6,841.87. These funds include fees paid in for the upcoming Walks.

Bud Broeker presented updates from the recent Board training including the following:

- The Upper Room will not make a new "Remembrance" video for Thursday night.
- Table Leaders and Assistant Table Leaders should be housed with pilgrims.
- The type of projects done after the talks should not be defined for the tables; they should be able to choose the type on their own.

Bud Broeker made a motion that the Board purchase 4 sets of Emmaus Manuals for Board members who do not have one. These would be passed down to the next person filling that Board position in the future. The motion was seconded by Bob Duplantis and carried.

Bud Broeker stated that permission was received from Upper Room to post a video about the Walk to Emmaus on the GAE4DG website. He will work on adding the video as well as the sponsor packet to the website.

Sandy Brooks stated that Gathering locations are confirmed through September. There was discussion of adding an Information Table at Gatherings to include Pilgrim and Team Applications, Sponsor packets, Prayer Vigil and Agape Sign Up sheets, and agape letters for signatures by the community.

It was decided that the Board would announce openings for 4th Day Speakers at Gatherings so that people who attend a church that is not the host can have the opportunity to speak. It will also be announced at the Gathering that the position of Music Coordinator is still available. Bob Duplantis will obtain a copy of the Board's By-Laws and distribute them to Board Members via email for review and the Board will return next month for suggestions and ideas for adding committee member positions on the Board.

Diane Merwarth reported that the Agape Needs List will be passed around at the Gathering and a link to the online sign up would be sent out through the Yahoo group. Diane Merwarth asked if childcare supplies could be stored on the trailer and it was agreed that they could be. Diane discussed the creation of a set of food safety guidelines for outside teams to ensure sanitary conditions of food and proper handling. Keith Bible will assist Diane with the creation of the guidelines. Refrigerators will be removed from the agape list since there are presently enough refrigerators available from the trailer and the Walk sites.

Leslie Smith made a motion that the Board purchase 2 pump air coffee pots, 2 30-40 cup coffee makers, and 1 timer. The motion was seconded by Sandy Brooks and carried.

Bob Duplantis reported that there has been difficulty in setting up services through Vertical Response because he has not been able to obtain a letter about the non-profit status of the organization.

Cortney Smith reported that there will be two Chrysalis Flights this summer (July 8th-10th for the Girls and July 22nd-24th for the Boys). Chrysalis is in need of a cook team for the Boy's Flight, a Marriage speaker for the Girl's flight, and the registration of butter-flies for both Flights. Announcements would be made at the Gathering regarding these needs.

Gene McConnell reported that there have not been any volunteers for a Nominating Committee to assist with suggesting new Board members. Names were suggested by the Board for the Assistant Lay Director and Spiritual Director positions.

Don Greenway and Keith Bible reported on the outcome of Walk 1541 and provided the following concerns/suggestions:

- On the Sunday morning schedule, the talk times are listed as 20 minutes and do not provide enough time to get to lunch on time. Bud Broeker stated that the schedule has been updated and is now being distributed to upcoming LDs.
- It was suggested that the Candlelight music team wait to break down equipment until after the Pilgrims have finished with their reflection time so as not to distract them.
- There should be a cross on the trailer specifically for St. Elsewhere Table pictures since the Conference Room cross can not be removed for pictures.
- The Lay Director's worship book had different text from the Pilgrim's in one of the responsive reading sections on Sunday morning.
- There was a request for guidance on how Dying Moments should be performed. It was stated that at the most recent Walk Flight Leadership Training the service was modeled for participants. Bud Broeker will find out if any additional guidance is available from the SWTX Conference.
- The new wooden crosses are easily broken. Bud Broeker will take this feedback to the SWTX Conference Emmaus Board.

Possible candidates for Lay Directors in 2011 were chosen and Bud Broeker will contact these individuals to find out if they are available and interested.

The board set the date of April 8th for the next board meeting to be held at Riverbend Church prior to the gathering that night. The meeting was adjourned at 7:00 PM with a closing prayer by Rev.
